Angolan Programs - In 2015, five schools were built with construction on several continuing into 2016. Construction of RISE schools provides jobs for laborers, apprentices, masons and project managers on building sites, as well as for teachers and principals. Shoes donated by TOMS were distributed to 5,630 children in schools in the Bie and Benguela provinces. Additionally, RISE received a grant for a small study to assess the impact of clean water on the health and mortality of children under age 5, in 6 villages near Kuito. The baseline survey took place in June 2015, results were analyzed, and wells were drilled and are in use in 3 of the villages. The See Form 990, Page 2, Part III, Line 4a (continued)
