Angolan Programs - In 2016, 6 schools were completed, with construction on one more continuing into 2017. Construction of RISE schools provides jobs for laborers, apprentices, masons and project managers on building sites, as well as for teachers and principals. TOMS Shoes were distributed to 10,320 children in schools in the Bie and Benguela provinces. RISE received a grant in 2015 for a small study to assess the impact of clean water on the health and mortality of children under age 5, in 6 villages near Kuito. The endline survey was implemented in July 2016, results assessed, and wells were drilled in the 3 control villages. Additionally, 2 wells funded by Rotary were drilled in the Benguela Province, and a natural spring is being tapped with funds from Willow Creek North See Form 990, Page 2, Part III, Line 4a (continued)

Since 2003, RISE has built 159 rural schools, providing the opportunity for education to over 106,000 children. RISE grants funds to RISE Angola for the oversight and administration of the program. The Angolan Ministry of Education hires and pays the teachers, and supplies textbooks, chalkboards and desks.
