contribute to the rebuilding of the country. RISE grants funds to RISE Angola for
oversight and administration of the program, and the building of schools.
RISE has built 191 schools, giving over 137,000 children access to
education each year.
The school year began in February but abruptly ended on March 20. Primary
schools remained closed throughout 2020 because of the pandemic.
Construction continued as building teams live and work at the school sites, and
were quarantined there. The final 6 of 26 schools, built as part of our co-funding
