Angolan Programs - In 2014, four schools were built and two wells were drilled at school sites. Construction of RISE schools provides jobs for laborers, apprentices, masons and project managers on building sites, as well as for teachers and principals. A team traveled to Angola to visit schools and sites, meet with our teams and document the work. Shoes donated by TOMS were distributed to 5,394 children in schools in the Bie and Benguela provinces. Since 2003, RISE has built 153 rural schools, providing the opportunity for education to over 100,000 children. RISE grants funds to RISE Angola for the oversight and administration of the program, building materials and skilled labor.
