Angola Programs - In 2013, six schools were built and one well was drilled at one of the sites. Construction of RISE schools provides jobs for laborers, apprentices, masons and project managers on building sites, and 1084 teachers and principals. A team traveled to Angola to visit schools and sites, meet with our teams and document the work, with two additional trips by the Executive Director in February & December. Shoes donated by TOMS were distributed to children in schools in the Bie and Benguela provinces. Since 2003, RISE has built 150 rural schools, providing the opportunity for education to over 98,000 children annually. RISE provides the funds See Form 990, Page 2, Part III, Line 4a (continued)
