contribute to the rebuilding of the country. RISE targets vulnerable and
marginalized children, who would not otherwise have the opportunity to go to
school. Since 2003, RISE has built 198 schools, giving over 144,000 children
access to education each year.
In 2024, RISE celebrated 21 years of building schools to give thousands
of children access to education. RISE continued to develop strategic
partnerships with Azule Energy, ExxonMobil, Governors, local
administrations, and the Ministry of Education (MED), which have
